SRHA has applied for additional vouchers to address the homeless population. In addition, when made available by HUD, the agency will apply for additional vouchers to assist the homeless. If awarded additional funding the agency will coordinate with the Continuum of Care to address the needs of the homeless persons (particularly chronically homeless individuals with families, families with children, veterans, and persons at risk of homelessness.</p> <p>The agency continues to seek resources from outside funding sources. Additionally, SRHA has and will continue to encourage Section 3 contractors to do business with the Agency. The Agency will also continue to support family self-sufficiency through the agency’s Family Self-Sufficiency Program and counseling services. Both the Housing Choice Voucher program and Public Housing Program have made significant efforts in marketing the Family Self-Sufficiency program. Recruitment and Program outreach includes flyers, posters and brochures in the office reception area and bulletin boards, inserts in recertification packets, interim and move-out packets, during inspection meetings, information tables at public areas and events and mass emails. In addition, one-on-one touchpoints such as recruitment at the initial voucher briefing or move-in as well as virtual orientations.</p> <p>Suffolk RHA seeks to bring about change in the community, to build partnerships, strategically invest in program innovations, and to anchor capital in communities by actively seeking redevelopment opportunities. By treating our team members, customers, and partners with mutual respect and sensitivity; we actively recognize the importance of diversity, respect all individuals, and value their contributions.</p>

Until such time as the PHA is required to submit an AFH, the PHA will not have to complete section D.; nevertheless, the PHA will address its obligation to affirmatively further fair housing in part by fulfilling the requirements at 24 CFR 903.7(o)(3) enacted prior to August 17, 2015, which means that it examines its own programs or proposed programs; identifies any impediments to fair housing choice within those programs; addresses those impediments in a reasonable fashion in view of the resources available; works with local jurisdictions to implement any of the jurisdiction’s initiatives to affirmatively further fair housing that require the PHA’s involvement; and maintain records reflecting these analyses and actions. HUD may not collect this information, and respondents are not required to complete this form, unless it displays a currently valid OMB Control Number.
