Purpose. The 5-Year and Annual PHA Plans provide a ready source for interested parties to locate basic PHA policies, rules, and requirements concerning the PHA's operations, programs, and services, including changes to these policies, and informs HUD, families served by the PHA, and members of the public of the PHA's mission, goals and objectives for serving the needs of low- income, very low- income, and extremely low- income families.

Applicability. The Form HUD-50075-ST is to be completed annually by **STANDARD PHAs or TROUBLED PHAs**. PHAs that meet the definition of a High Performer PHA, Small PHA, HCV-Only PHA or Qualified PHA do not need to submit this form.

Definitions.

- (1) **High-Performer PHA** – A PHA that owns or manages more than 550 combined public housing units and housing choice vouchers, and was designated as a high performer on both the most recent Public Housing Assessment System (PHAS) and Section Eight Management Assessment Program (SEMAP) assessments if administering both programs, or PHAS if only administering public housing.
- (2) **Small PHA** - A PHA that is not designated as PHAS or SEMAP troubled, that owns or manages less than 250 public housing units and any number of vouchers where the total combined units exceed 550.
- (3) **Housing Choice Voucher (HCV) Only PHA** - A PHA that administers more than 550 HCVs, was not designated as troubled in its most recent SEMAP assessment and does not own or manage public housing.
- (4) **Standard PHA** - A PHA that owns or manages 250 or more public housing units and any number of vouchers where the total combined units exceed 550, and that was designated as a standard performer in the most recent PHAS or SEMAP assessments.
- (5) **Troubled PHA** - A PHA that achieves an overall PHAS or SEMAP score of less than 60 percent.
- (6) **Qualified PHA** - A PHA with 550 or fewer public housing dwelling units and/or housing choice vouchers combined and is not PHAS or SEMAP troubled.

In Chapter 2 – Fair Housing, new language added to PHA policies related to persons with disabilities. Eligibility - Deleted language to PHA policy on criminal activity and added new language to PHA policy on previous behavior. Among applicants with the same preference, applicants will be selected based on the date and time of the application from the waiting list SRHA.</p> <p>Financial Resources - See attachment 1.</p> <p>Rent Determination - In Chapter 6 of the ACOP, Income, language added to PHA policy SSA COLA, added language to PHA policy on reasonable childcare costs, utility allowances.</p> <p>Homeownership Programs – SRHA continues to look for innovative ways to provide and promote affordable housing. To do so, SRHA has acquired a property through a foreclosure sale and will renovate the single-family home to further affordable housing.</p> <p>Community Service and Self Sufficiency Programs - The Family Self-Sufficiency Action plan was revised and approved November 2022. The Resident Services department is committed to encouraging residents to be more active in healthy eating by providing programs such as food pantry and growing partnerships with the Food Bank and Salvation Army. Also presently setting up a community garden in our Chorey Park Community to encourage growing your own vegetables. In partnership with Eastern Virginia Medical School (EVMS), resources are made available to residents on mental health. Continuing to provide opportunities for COVID testing and vaccinations as well as smoking cessation. Funds generated will be used to create additional affordable housing opportunities. Staff applied for the Capital Funds Risk Grant for Hoffer Apartments. Unfortunately, we were not one of the agencies selected for the grant. ➤ Increase the number of individuals/families that become self-sufficient. <ul style="list-style-type: none"> 2.2 Create a marketing plan to encourage individuals to attend self-sufficiency programs. Both the Housing Choice Voucher program and Public Housing Program have made significant efforts in marketing the Family Self-Sufficiency program. Recruitment and Program outreach includes flyers, posters and brochures in the office reception area and bulletin boards, inserts in recertification packets, interim and move-out packets, during inspection meetings, information tables at public areas and events and mass emails. In addition, one-on-one touchpoints such as recruitment at the initial voucher briefing or move-in as well as virtual orientations. 2.4 Apply for additional funding to create more personnel to assist with case management. SRHA was awarded funding to support an additional full-time Family Self-Sufficiency Program Coordinator position. The award received was \$104,736 to cover two-positions for the 2022 calendar year January 2022-December 2022. An additional award was received to cover both position for the FY2022 grant for the period of January 2023 – December 2023. 2.5 Create a Financial Management Plan with each participant (i.e., budgeting, home ownership, etc.) The Housing Counselor has assisted participants with establishing a budget to work towards homeownership, those that own homes were assisted with debt consolidation and mortgage foreclosure prevention. ➤ Expand redevelopment activities and lead efforts to develop a continuum of housing options. The White Marsh Point at Eagle Landing project consists of the renovation of 113 units and the demolition and reconstruction of 93 units with a community room. The renovations at Eagle Landing have been completed and all units have been reoccupied. The construction of 93 units at White Marsh Pointe is progressing well although we have continual obstacles presenting themselves due to the COVID pandemic (lack of works, lack of material, material delays, etc.) we have been able to obtain temporary certificates of occupancy for many of the buildings. The total cost of the project, structured as a Low Interest Tax Credit Community (LIHTC), is estimated at \$46.3 million, financed by a mixture of tax credits, a loan from SRHA, a \$275,000 contribution from the City of Suffolk, and grants from the Federal Home Loan Bank of Atlanta totaling \$1,000,000. HUD endorsed the FHA-insured mortgage on the project of \$23.1 million.

	<p>3.1 Increase capacity to meet demand for affordable rehabs. The Owner-Occupied Housing Rehabilitation/Reconstruction program was developed to assist existing homeowners with needed repairs that are above and beyond the Emergency Home Repair Program scope. The program will provide deferred loans and low interest loans to homeowners so that necessary repairs for their health, safety, and welfare.</p> <p>3.4 Identify and engage stakeholders for development. In February 2022 the agency has done an RFP to create and expand the supply of affordable housing. The objective is to award project-based vouchers through a competitive application process to developers, developing communities in our jurisdiction. The agency plans to pursue partnerships with developers or entities to further the goal of creating additional affordable housing opportunities. Expanding the availability of decent, safe, and sanitary affordable housing by providing project-based vouchers to developers.</p> <p>In 2020 the agency obligated some of its housing choice vouchers through the RFP process to developers in accordance with 24 CFR 983.6 (d) to project base vouchers to provide alternate affordable housing opportunities for families in the City of Suffolk. The agency continues to work with developers to ensure environmental review and subsidy layering reviews are conducted to prevent excessive public assistance from other local, state, and federal housing agencies.</p> <p>The PBV award was awarded to a developer in March 2022 however the developer decided not to move forward with the project. This continues to be an ongoing goal for the 2023 year.</p> <p>3.5 Identify affordable housing location/projects and assist in reinforcing compliance.</p> <p>SRHA received a commitment through the Virginia Housing to participate in the "Acquire, Renovate and Sell" program which would provide interim construction financing for renovations prior to selling the home to an eligible homebuyer. Recently, a contract amendment was executed to extend the termination date of the program due to the lack of affordable housing nationwide. We will utilize the program to undertake the renovations of a home that we purchased at a foreclosure sale. Additionally, we are actively looking for properties to acquire however, the current housing prices however, due to the current sales prices of homes we have not been successful in acquiring a property.</p> <p>SRHA has applied for additional vouchers to address the homeless population in October 2022. In addition, when made available by HUD the agency will apply for additional vouchers to assist the homeless. If awarded additional funding the agency will coordinate with the Continuum of Care to address the needs of the homeless persons (particularly chronically homeless individuals with families, families with children, veterans, and persons at risk of homelessness).</p>

This was because the Authority's unaudited submission to the Real Estate Assessment Center contained material errors relating to financial activity of the component unit. Material component unit activity, including the acquisition and financing of a LIHTC project, was omitted from the Authority's financial statements.</p>

No additional comments were received for Capital Fund Improvements. Response: All projects listed above are in the Capital Fund 5-year plan. One resident of Hoffer Apartments commented that Capital funds project should use fund to remodel and replace everything in each unit of Hoffer Apartments. Capital fund projects should use funds to have a place for the children in the community to go and do activities, build self-esteem, inspire to be youthful, healthy, safe, and confident. This space can be connected to rental office. Funds should be used for basketball court. Response: The needs within the development are far greater than funding available and projects are planned to upgrade kitchen and bathrooms, replace the heating and air condition units, faulty window replacement, and vinyl siding and roof gutter replacement. A new playground set was installed several years ago for the enjoyment of the children. There is a basketball court and community center in this community; however, they remain closed due to the COVID-19 pandemic. Two residents of Colander Bishop Apartments mentioned the need for new plumbing and drain lines and were in support of Capital Funding to replacement of the roofing, roof gutters, vinyl siding replacement, replacement of windows, replacement of heating and air conditioning units, kitchen & bathroom upgrades & renovations, and parking lot repaving.</p>
